- 2. <u>Dallas Township Planning & Zoning Training:</u> Legal counsel sent an email regarding the need to have a joint training session for instructions on planning and zoning. This training would include the Township Board; Planning Commission and Zoning Board of Appeals.

- 3. <u>Dallas Township Budget Adjustment 2014-15:</u> T. Koenigsknecht stated that per Auditor Bill Tucker, the township should do a budget adjustment to add 206-000-673-000 Sale of Capital Assets in the amount of \$13,000 to the 2014-15 budget since the tanker was sold to Hubbardston Village before March 31, 2015. A motion was made by S. Schafer, supported by V. Feldpausch to approve adding 206-000-673-000 for \$13,000 to the 2014-15 budget. Motion carried.
- 4. <u>Dallas Township 2015-16 Proposed Budget Review:</u> The township board reviewed the 2014-15 revenue and expenditure reports for month ending March 31, 2015 to determine budget amounts for 2015-16. All department line items for 2014-15 were under budget and the township board was pleased with this.
