## REPORTS:

<u>Fire Dept:</u> V. Feldpausch stated fire/rescue runs have been slow the past month.

<u>Clerk:</u> T. Koenigsknecht completed W2 and state forms; revenue & expenditure reports for month ending 1/31/17; worked on FD budget amendments and working in QVF on street indexing problems with village.

<u>Treasurer:</u> A. Schafer stated she has collected 77% of the taxes so far for \$864,669.60; and had questions regarding property forfeiture she received from County Treasurer today.

<u>Supervisor:</u> V. Feldpausch is working on several land divisions: budget work; BOR with Assessor; CAASA meeting; and working with insurance company regarding ISO rating improvements.

### **UNFINISHED BUSINESS:**

- 1. <u>Wind Turbines:</u> No news from attorney, however, Supervisor & Clerk both received calls from DTE asking about feasibility of wind turbines in Dallas Township. They were directed to the township website to obtain that information from the Interim Zoning Ordinance.
- 2. Medical Marihuana: No news on this item.

### **NEW BUSINESS:**

- 1. <u>County Commissioner Report:</u> Commissioner Pohl stated DTE may be showing interesting in twp due to 10% to 15% green energy will be required by 2020; looking favorable for County to gain State of MI contract for inmates; SJ Schools approached County regarding RBW; tech update at County upward of \$143,000 including new cameras in the jail and new computers in police cars.
- 2. Zoning Administrator's Report: Board members briefly discussed Ms. Foster's activity report.
- 3. <u>MTA Conference April 10-13, 2017:</u> A motion was made by T. Koenigsknecht, supported by S. Schafer to approve township board members permission to attend MTA Conference in Lansing, MI this year. Motion carried.

Schafer, supported by A. Schafer to approve G. Goerge, D. Thelen and D. Schafer as members of the 2017 Board of Review. Motion carried.*

- 5. <u>Planning Commission:</u> S. Schafer reported that the Planning Commission continues to go through Interim Zoning Ordinance to make it a permanent zoning ordinance. Township Attorney will attend Planning Commission meeting in March in hopes of finalizing the Ordinance. A motion was made by S. Schafer, supported by A. Schafer to approve the addition of Kurt Marvel to the Planning Commission. Motion carried.
- 6. <u>2017-18 Budget:</u> Township board members went through revenue and expenditures reports and will discuss more at the March 7<sup>th</sup> meeting.
