<u>Supervisor:</u> V. Feldpausch worked on two land divisions; has been in contact with Board of Review members and checked on tanker.

- 2. <u>Tanker:</u> V. Feldpausch visited ETanker expected delivery approximately mid-January. A few additional items such as steel bumper were added and company was penalized from November 15th \$100 per day.

NEW BUSINESS:

- 1. <u>Dallas Township Zoning Administrator:</u> Reviewed report no comments.
- 2. <u>Clinton County Commissioners Report:</u> Commissioner Pohl stated the County finished the year in good shape; officers are staying the same; union contracts are complete; 2% increase and all have agreed to participate in the health care program and revenue for 2016 is \$20.5 million.
- 3. <u>Board of Review Member Appointments:</u> All 3 agreed to be renewed this year Dale Thelen; Dick Schafer and Gene Goerge. **A motion was made by V. Feldpausch, supported by P. Schafer to approve the 3 Board of Review Members. Motion carried.**

Public Comments:

Spoke about RESA students attending trainings/rescue runs in the middle of night or after school and liability coverage for this. Church bulletin article worked well as rural recycling site contamination issue seems resolved; budget adjustment for Planning Commission will need to take place. Next Planning meeting is March 21, 2016 @ 7:00 pm.
