<u>Fire Dept:</u> V. Feldpausch stated there was another meeting with the chassis company with possibly trading in the old tanker; awaiting a bid from another company. Fire Dept. has been very busy and nearing the mid-60's in run totals; a grant was written by the FD for a \$5000 grant for an off-road vehicle.

<u>Clerk:</u> T. Koenigsknecht worked with Patti Schafer on June 11th to prepare for upcoming audit preparation; 2nd quarter payroll; election training on June 18th; preliminary test and many hours on Election work.

<u>Treasurer:</u> G. Arens stated tax collections have begun, delinquent personal property tax letter went unclaimed; Treasurer will be gone from July 21 – 30th and will have everything paid out by the time he leaves; discussed disgruntled taxpayer upset that Township Assessor did not return his calls.

<u>Supervisor:</u> V. Feldpausch stated he handled many calls from disgruntled taxpayer regarding lack of chloride on the roads; working with CC Road Commission on blown out tiles in the township; and more land divisions throughout Clinton County.

UNFINISHED BUSINESS:

- 1. <u>Wind Turbines:</u> Ken Wieber sent an email to T. Koenigsknecht on June 22nd with a letter from a McBain woman regarding ill and asked that this letter be entered into the official July township minutes (page 3); the wind turbine lawsuit is still in the appeals process and the Oral Arguments will be heard next Wednesday, July 16th at 11:00 am in the Hall of Justice in Lansing, MI. Township Board asked Clerk to forward Ken Wieber letter to Bill Fahey.
- 2. Hall Rental Policy: Tabled.

NEW BUSINESS:

- 1. <u>County Commissioner Report:</u> Mobile homes were finally moved out of Capitol Crossings Park; heard that Drain Office is looking into water situation; Eaton County approved putting on the ballot a 1.5 mill for the roads and asked the township board how they felt about Clinton County doing this; Rails to Trails is progressing very well between Grange and Hinman Roads.
- 2. MML Work Comp Trustee positions: T. Koenigsknecht disbursed a mailing from MML which states that three (3) people (incumbents) are running for three (3) trustee positions on the Work Comp ballot, for a two (2) year term beginning October 1, 2014. A motion was made by V. Feldpausch supported by S. Schafer to support the three (3) incumbents for the Board of Trustees election through the MML. Motion carried.
- 3. <u>Purchase Agreement Purchase of 2.5 Acre Lot:</u> V. Feldpausch asked the interested party in attendance if they could wait one month before acting on the sale of this lot as he will contact Lori (Pettit) Hartley regarding this. V. Feldpausch motioned, supported by P. Schafer to table this until the August meeting. Motion carried.

Good Morning IICC Supporters!

The letter below appeared in the Cadillac News this week.

As you know, wind leaseholders take a risk when speaking out about the ill effects of wind development due to "gag clauses" in the lease language.

I applaud the courage of this lady for speaking truth.

There are those who would say "I would rather a wind plant than a nuclear power plant in my back yard!"

But the truth is that nuclear power plants only harm people when they malfunction.

Wind plants harm people when they are operating normally.

And another question arises: what is the right percentage mandate for devices that continue to cause this harm to Michigan's rural residents?

Bottom line: MI has spent \$2.5 billion on wind + transmission to have reduced coal emissions by a few percent at best.

That same money spent on clean burning gas-fired generation could have cut our PM2.5 and Hg emissions by HALF while reducing CO2 emissions by 25%.

What kind of environmental return is that?

BTW: Heritage is busily attempting to build more wind projects in the state with similar setbacks to those in McBain, despite a demonstrable track record of failing to protect our rural residents.

It is an injustice to use zoning policy to award private property to industrial wind developers for use as nuisance and safety buffers with neither consent nor compensation.

"I signed a wind turbine lease in 2008. If I had known then what I know now, I wouldn't have signed.

Since the turbines went up I have had frequent headaches lasting three days. I never had these before. My mother has ringing in her ears and headaches. I have spoken to others in the community who have been affected by the turbines. One has dizzy spells. Another does not feel healthy until she leaves McBain. They are now planning on moving, but have been told by realtors that they will have trouble selling their home because of the turbines.

Because it takes so long for the entire wind farm to become operational, the signs of how the turbines worsen health and quality of life take a long time to be noticed. One person I talked with thought her dizziness was "just getting older," but this person is young.

Why hasn't anyone spoken out before? People are afraid of being shunned. They don't want anyone to know they are having problems.

Is money more important than health? Is this what we gave away for \$10,000 a turbine and monthly payments, with leases that will never end? We gave up our beautiful community, we are giving up our health, our electric bills have risen, and there doesn't seem to be anyway out except leaving.

The wind companies have talked to people in McBain and I believe they know there are problems with noise and with health. Why don't they take action? Why didn't they tell us about the health problems before we signed leases?

I now believe that the only safe place for turbines is at least a mile and a half from anyone's home."
