#### **REPORTS:**

Fire Dept: V. Feldpausch stated the fire department has been busy; took new tanker to a structure fire.

<u>Clerk:</u> T. Koenigsknecht spending time on FOIA requests for 2015 wages; working with MTA attorney on fire department millage language; many incoming absentee ballot requests; performed first MOVE military ballot; public accuracy test yesterday, and worked on month ending revenue & expenditure reports.

<u>Treasurer:</u> G. Arens has wrapped up winter 2015 taxes; collected 1238 of 1277 for 96.9%; \$1,053,046 of \$1,083,166 for 97.2% and 40 parcels are delinquent. G. Arens also informed the township board that he will not be seeking re-election this year.

<u>Supervisor:</u> V. Feldpausch worked on 2 land divisions; spoke to Assessor and was informed that residential went up 1.3% and agricultural went up higher.
