<u>Fire Dept:</u> C. K-13 reported Mark Halfman & Scott Milner retired as of October 31st; Martin Olney, R.J. Drabek and Ken Lieby are the new members of the FD; tanker should be delivered by November 15th. He also stated the current JAWS spreader is heavy & very cumbersome. FD advised they will use \$4800 from FD Emergency Fund to put towards \$7900 cost for a new spreader & asked if half the amount of the spreaders could be taken from fire department budget. **G.** Arens made a motion, supported by **P**. Schafer to allow the FD to order a new Jaws of Life spreader and allow half the amount from the FD budget. V. Feldpausch abstained from the vote. Motion carried. As soon as tanker is delivered, DNR will turn over the title to the township.

<u>Clerk:</u> T. Koenigsknecht prepared for Workers Comp Payroll Audit on 10/20/15 – audit went well: sent out letters to FD employees to update life insurance beneficiaries; worked on obtaining titles for 1994 and 2006 FD vehicles; and preparing items for March Presidential Primary.

<u>Treasurer:</u> G. Arens attended the County-wide Treasurer's meeting; worked on winter taxes/newsletter and spoke to Board regarding balance needed in the Tax Account. T. Koenigsknecht will contact auditor for his input.

<u>Supervisor:</u> V. Feldpausch is working on a land division with resident; worked with Assessor & Zoning Administrator; met with Joe Thomas on tanker and received insurance audit paperwork and will get township information to Clerk; spoke to fire dept regarding the option of having April 1 – March 31st budget year.
