Call to Order: The meeting was called to order by Supervisor Feldpausch at 7:00 p.m. followed by the Pledge of Allegiance.

Recognition of Guests: Listed above.

Minutes of Meeting – August 9, 2016: G. Arens asked for correction of minutes under his report. It should state, "1303 parcels collected thus far (of money collected)." Also, under adjournment, it should read "supported by P. Schafer". A motion was made by G. Arens, supported by V. Feldpausch to approve the minutes from the August 9th monthly board meeting with corrections as noted. Motion carried.

Additions or Correction to Agenda/Approval of Agenda: A motion was made by G. Arens supported by V. Feldpausch to approve the agenda. Motion carried.

Approval of Bills: A motion was made by G. Arens, supported by V. Feldpausch to approve the payment of General Fund bills in the amount of \$10,296.02 and the Fire Department bills in the amount of \$1289.14. Motion carried.

#### REPORTS:

Fire Dept: V. Feldpausch stated the new tanker has developed a leak and rep from ETanker Rep contacted and will take care of it.

<u>Clerk:</u> T. Koenigsknecht has been in contact with attorneys regarding FD rescue proposal; updating voter cards for November election, finishing audit work and requested permission from Board to purchase Microsoft Office 2016 Business Program for \$209 due to Outlook issues. *Motion made by G. Arens & supported by V. Feldpausch to approve \$209 for the Microsoft Outlook computer program.*Motion carried.

<u>Treasurer:</u> G. Arens stated he is working on finishing the tax collection season. So far, 624 out of 1303 has been collected (47.8%) and \$471,979 out of \$950,336 (49.6%). He has been training with Deputy Treasurer, Ann Schafer and stated last month cash flow charts showed interest rates have been going up for Michigan Class.

<u>Supervisor:</u> V. Feldpausch has been working with moving forward with the grant through the insurance company, \$3385.00 has been requested, however, \$2950 is the amount insurance will give; met with CCRC on chloride application; and Clerk and he met with Greenbush Twp. officials.

#### **UNFINISHED BUSINESS:**

- 1. Wind Turbines: No news.
- 2. <u>Millage Renewal/Proposal Discussion</u>: There was discussion as to the date the rescue run proposal should be implemented. **A motion** was made by V. Feldpausch, supported by G. Arens to table this topic until October when the full Board will be present. Motion carried.

- 1. <u>County Commissioner Report:</u> Cell tower should be up and running late October; Greenhaven Youth Facility should be finished by end of this month; discussed long-term 4H Fair plans; looking for parks/greenspace in the southern part of the County; and .2 mils for Clinton Transit will be on the November ballot.
- 2. <u>Dallas Township Zoning Administrators Report:</u> Members viewed report and a short discussion followed.
- 3. <u>Conflict of Interest Resolution:</u> T. Koenigsknecht suggested since a full Board is not present, this Resolution should be tabled until the October meeting. *A motion was made by V. Feldpaush, supported by G. Arens to table this topic until October when full Board will be present. Motion carried.*
- 4. <u>L-4029 Tax Request:</u> T. Koenigsknecht stated the L-4029 Money To Be Raised By Taxes is completed and needs Board approval before sending in. *A motion was made by V. Feldpaush*, supported by G. Arens to approve the 2016 L-4029. Motion carried.
